PARKS AND RECREATION COMMISSION: MEETS ON THE SECOND WEDNESDAY OF THE MONTH AT 7:00 PM AT THE OAKLAND TOWNSHIP HALL, 4393 COLLINS ROAD, ROCHESTER, MICHIGAN. MEMBERS ARE ELECTED OFFICIALS THAT ARE RESPONSIBLE FOR THE TOWNSHIP'S PARKS AND OPEN SPACE PRESERVATION AND HAVE DEDICATED MILLAGES FOR THAT PURPOSE.

IT HAS A DEDICATED MILLAGE FOR THAT PURPOSE

HISTORIC DISTRICT COMMISSION: MEETS ON THE THIRD WEDNESDAY OF THE MONTH AT 7:00 PM AT THE OAKLAND TOWNSHIP HALL, 4393 COLLINS ROAD, ROCHESTER, MICHIGAN. MEMBERS ARE APPOINTED BY THE TOWNSHIP BOARD AND ARE RESPONSIBLE FOR THE PRESERVATION OF HISTORIC RESOURCES THROUGHOUT THE TOWNSHIP AND HAVE A DEDICATED MILLAGE FOR THIS PURPOSE.

BOARD OF REVIEW: MEETINGS ARE SET BY STATE STATUTES IN MARCH, JULY, AND DECEMBER TO HEAR PROTESTS OF ASSESSED AND/OR TAXABLE VALUES OF REAL AND PERSONAL PROPERTY AND TO CORRECT CLERICAL ERRORS AND OMISSIONS. MEETINGS TAKE PLACE AT THE OAKLAND TOWNSHIP HALL.

MEMBERS ARE APPOINTED BY THE TOWNSHIP BOARD. THE COMMITTEE IS A RECOMMENDING BODY TO THE TOWNSHIP BOARD REGARDING MATTERS UTILIZING THE TRAIL SYSTEM MILLAGE FUNDS.
