### SUMMER TAXES

Payable July 1, 2019 through September 16, 2019  
1% Interest September 17 – 30, 2019  
Plus 1% Interest per Month, thereafter.  
Additional 3% Penalty February 15 - March 2, 2020

Beginning March 3, 2020, all unpaid 2019 taxes must be paid to:  
Oakland County Treasurer

### DEFERMENT OF SUMMER TAXES

Summer taxes may be deferred until February 14, 2020, if your 2018 total household income did not exceed \$40,000 and you meet one of the following requirements:

- Senior Citizen, age 62 or older
- Hemiplegic, Paraplegic, or Quadriplegic
- Eligible Serviceperson, Veteran, Widow or Widower
- Blind
- Totally and Permanently Disabled

Applications for deferment are available at the Treasurer's Office and must be returned by September 16, 2019

**Debit or Credit Cards:** You will be charged a **CONVENIENCE FEE** of 2.75% based on the amount of your tax. (For amounts  $\geq$  \$1,000) For amounts  $<$  \$1,000 see fee schedule at [www.paylocaltaxes.com](http://www.paylocaltaxes.com)

**E-Check:** You will be charged a **FLAT FEE** of \$2.50.

### BY PHONE

Call the 24 Hour Tax Hotline at 248-858-0025 and follow the instructions. Debit, Credit or E-Check Payments are accepted. The same convenience fees apply as above.

### IMPORTANT TAX INFORMATION

Make sure your Homeowner's Principal Residence Exemption Affidavit and Property Transfer Affidavit are filed with the Township.

Check your parcel I.D. number with your deed or land contract. If you pay on the wrong property, the law holds you fully responsible.

**Failure to receive a tax statement does not exempt taxes from interest and penalty.**

We accept partial payments until March 2, 2020. As of March 3<sup>rd</sup> all taxes must be paid at the Oakland County Treasurers office.
