**DOG LICENSES**

2016 dog licenses expire December 31, 2016  
2017 dog licenses are now available at the Treasurer's Office.  
To obtain a license,  
**proof of spayed or neutered  
and current rabies vaccination is required.**  
Dog licenses are good for the entire calendar year.  
If purchased after June 1<sup>st</sup>, a delinquent fee will be charged.

Call the 24 Hour Tax Hotline at 248-858-0025 and follow the instructions. Your payment will be effective on the date you make the charge. **Credit card payments by phone are accepted through February 28, 2017.**

**IMPORTANT TAX INFORMATION**

Make sure your Homeowner's Principal Residence Exemption Affidavit and Property Transfer Affidavit are filed with the Township.

Check your parcel I.D. number with your deed or land contract. If you pay on the wrong property, the law holds you fully responsible.

Failure to receive a tax statement does not exempt taxes from interest and penalty.

You should receive your 2017 Assessment Notice by March 1, 2017.
